III. Circumstantial evidence.

A. Will Durant - what happened concerning the birth of the Church was a miracle in itself.

B. The Church's survival - the whole foundation of the church was that based upon the resurrection of Christ.

C. The change in worship from the Jewish Sabbath on Saturday to the Lord's Day - Sunday. No Jew would have been willing to break this Old Testament Law, but reverent Jews went so far to meet on Sunday as a testimony beyond any doubt that Christ was raised from the dead. Jews believed that God would have destroyed them if they were wrong about Jesus for breaking the Sabbath.

D. Baptism - only an empty tomb gives any meaning to this practice because we image His death and resurrection through it.

E. Communion - in this practice the death, burial and resurrection of Christ is celebrated. This is an early practice that was based upon the joy of the resurrection.

F. Changed lives - people of every background undergo change when they accept Jesus Christ into their lives. This is more than positive thinking. The speaker himself underwent this change.

G. The resurrection of Christ proved Jesus' Messiahship and His Sonship to God. It also confirmed that every sin had been dealt with before God. (Romans 4)
